## RULES AND REGULATIONS

---

---

1. A Brome County Agricultural Society exhibitor fee entitles the holder to exhibit in all sectors of the fair.
2. All exhibitors paying the \$25 exhibitor fee will be entitled to admission as follows: one four-day pass, one parking pass if available.
3. Exhibitors will receive the following additional 4-day passes:  
Cattle & horses- one per three head  
Sheep & goats- one per flock or herd of six  
A max of 3 additional 4-day passes may be given per exhibitor
4. We reserve the right to charge a 10\$ administration fee for entry submitted after August 10th.
5. Exhibitors Certificate of Insurance (minimum \$1,000,000) must accompany entry forms.
6. Persons intending to compete at Brome Fair must submit the entry form, required funds, and insurance certificate (if applicable), to the Brome County Agricultural Society office to the attention of the administration by August 10th before 8 p.m. The post mark will not be considered. Postdated cheques are not accepted. Any incomplete entry can be refused.
7. Monday Departure Times:  
Beef, Horses: 3 p.m.  
Dairy: 5:15 p.m.  
Goats, Sheep: 5:30 p.m.

Campers: 8 p.m.

Any exhibitor loading animals before, will forfeit any prize money, entry fees and will not be allowed to return for the following two (2) Fairs.

8. Every exhibitor of the Society will be liable to take the following oath if required by any member of the Society: "I do solemnly swear that all animals and/or articles exhibited by me are either my own or made or acquired by me according to the rules of this Society, so help me God".
9. No article or animal shall be entered for more than one premium in the same year, except for horse performance classes, special prizes or as provided for in herd and group classes.
10. No competitor shall be entitled to more than one premium in the same class unless otherwise stated.
11. Any member exhibiting an article for premium contrary to the rules of the Society will forfeit all prizes awarded him that year.
12. All animals and articles entered for competition shall be ticketed and numbered and no person shall in any way interfere with the judges in the execution of their duties.
13. All prize ribbons which have been awarded by the judges must be displayed during the fair. Any infraction of this rule will ensure forfeiture of any premium awarded.
14. Any member of the Society found guilty of loaning or otherwise giving use of a Society badge to another person, shall forfeit all premiums obtained by him during the year.
15. Any and all questions of dispute that may arise shall be referred to the president and administration of the Society.
16. Any exhibitor lodging a protest must make it in writing, and it must be delivered to the president or the administration within three hours of the cause of protest. This must be accompanied by a deposit of \$30 in cash. If such protest is sustained, the deposit will be returned; if not, it will be forfeited to the Society.
17. The Society will not be liable for any bills or accounts for any prizes won that are not presented or sent to the administration within two months from the close of the year, 31st October, in which said accounts become due or said prizes won.
18. In the event of the Society having not enough funds to pay the prizes in full, the Directors reserve the right to deduct the necessary percentage.

19. All trophies must remain on grounds and returned to the office Monday night of Brome Fair.
20. House trailers: Parking will be reserved for the exhibitor's house trailer, but it must have the sanitary implements. All trailers/campers must have a functional fire extinguisher. In order to defray costs, a rental fee of \$50 per camper will be required. Reservation and payment must be made with the entry form before 8:00 p.m. August 10th.
21. Brome County Agricultural Society membership is due each year at the annual meeting. The next annual meeting will be Saturday, December 3<sup>rd</sup>, 2022.
22. All prize cheques must be cashed by October 31st of the current year.
23. All prize cheques will be mailed out after fair.

## **RULES FOR THE JUDGES**

---

1. Judges shall be appointed by the officers and directors of the Society.
2. No person shall be allowed to act as judge who is in any way connected with the exhibit to be examined.
3. Judges are expected, in the execution of their duties, to be careful to act with the most rigid impartiality and to respect scheduled times and keep classes running accordingly.
4. Judges shall award premiums to the best manufactured article of its kind.
5. Judges shall, in awarding premiums on bulls, cows and heifers, have reference to the quality of such animals for improving stock and/or for dairy purposes.
6. Should there be one exhibit in a class or section; judges can use their own discretion as to awarding a premium. In all cases where they do not think the exhibit worthy, they can withhold the premium. Judges shall in no case award a prize unless they consider the exhibit worthy of such a premium.
7. Ownership of an exhibit shall not be in evidence during judging.
8. Any person not authorized to do so; conversing with the judge while on duty or otherwise interfering will forfeit any right he may have for a prize. It shall be the duty of the judge to report to the administration, on hand in the books, any infringement of the rule.
9. Upon discovery of any fraud, deception, dishonest practice, or misrepresentation regarding any exhibit, which may have influenced or been intended to influence the decision of the judge, the executive committee has the power to withhold payment of the prize awarded.
10. Any person who shall attempt to interfere with the judge in the performance of his duties, or shall afterwards, on the premises of the Society, use any abusive language to any judge in consequence of an award made by him, shall forfeit his right to any premium to which he might otherwise be entitled. Said person will also be excluded from exhibiting for one year thereafter. Judges are particularly requested to report any such breach of this rule

# **ANIMAL WELFARE POLICY**

---

---

## **Philosophy**

The Brome Country Agricultural Society (BCAS) believes that each animal participating in its activities must, at all times, receive proper care and management in the best interest of their welfare.

### **Animal welfare is considered satisfactory if the following five criteria are met:**

1. Absence of hunger, thirst and malnutrition.
2. Freedom from fear and distress.
3. Absence of physical and thermal stress.
4. Absence of pain, injury and disease.
5. Opportunity for the animal to express the normal behaviours of its species.

It is the policy of the fair that all animals are free of prohibited substances.

BCAS highly recommends that all animals be vaccinated as per veterinary recommendations.

## **Health Verifications**

BCAS reserves the right to require health inspections, proof of vaccination and/or that diagnostic tests be made at anytime prior to or during fair.

- The health condition of animals, as determined by the fair veterinarian, shall be final and cannot be protested.
- Animals will be rejected if evidence of infectious, contagious, or parasitic disease is apparent or if health certification and/or identification documentation are not accepted.
- Exhibitors who refuse to allow their animals to be examined shall be disqualified. No refunds will be made.

## **Animal Care and Management**

The care, custody and control of animals is the sole responsibility of the owner and/or exhibitor.

BCAS authorized personnel will only take charge of animals brought onto the fairgrounds in the event of an emergency or other urgent circumstances.

BCAS, in collaboration with the official fair veterinarian, reserves the right to require that animals deemed unsuitable for public display and/or in distress, be taken to a location designated by the fair and/or removed from the fairgrounds.



## **Guidelines:**

### **1. Restraining Animals:**

- a. Animals should be tied or penned in a manner that will not hurt the animal or restrict its breathing in any way.
- b. Animals should be tied so all its feet are firmly on the ground, and they have enough room to stand comfortably and lie down.
- c. Animals should be tied so they cannot injure animals tied near them.
- d. Animals unaccustomed to each other should not be penned together.

### **2. Handling:**

Any type of rough handling which could harm the animal is prohibited. The use of whips, canes and show sticks should be restricted to showing only and then be used only to guide, not punish the animals. The animals respond quicker and better to quiet, gentle handling, than loud, rough handling.

### **3. Bedding:**

All animals should have bedding that is dry and clean. Pens should be cleaned regularly to keep the animals clean and comfortable. If non-traditional bedding, such as carpet is used, it should be regularly cleaned (at least twice daily) to keep the pen free from manure.

### **4. Feeding and Water:**

Animals should be well fed and have access to clean water regularly. Animals not allowed reasonable access to feed and water will be disqualified from the event.

### **5. Transportation:**

Animals should be transported in a way that is both safe and considerate of the animal's wellbeing.

### **6. Blankets and Sweat Collars:**

Any type of material such as blankets or sweat collars should be large enough to permit normal body functions such as breathing, eating, drinking or lying down.

### **7. Health:**

It is the responsibility of the exhibitor to provide proper health care for their animals through routine inspection and consultation with health care professionals. The improper or illegal use of drugs or antibiotics is prohibited. If medication is indicated, be sure to follow the label.

## **Emergency procedures**

In the event of an emergency BCAS authorized personnel, in collaboration with the show veterinarian, will be responsible for resolving problems in areas reserved for animals or during competitions.

## **Escaped Animal:**

- If an animal escapes from its designated containment area, the owner/exhibitor and BCAS authorized personnel will make every effort to confine the animal as quickly as possible.
- If necessary, fair security will secure the perimeter and handle crowd control.
- If the animal escapes from the fairgrounds, fair security and the police department should be advised.

## **Injured or Dead Animal:**

If an animal on the fairgrounds is injured or dies, the designated veterinarian will be notified immediately to coordinate a quick, expeditious and appropriate response.

If emergency action is required prior to the arrival of the veterinarian, authorized BCAS personnel will ensure that the animal is moved to a designated location for evaluation as quickly as possible.

- A stall/area in the livestock and horse areas will be set aside for the treatment and/or evaluation of injured or sick animals.
- A wagon/trailer will be available to move an animal to the designated area if necessary.
- If an animal dies on the fairgrounds, it must be loaded onto a wagon/trailer and covered with a tarp for removal from the public area to a designated area. BCAS personnel and the veterinarian will assist the exhibitor and coordinate the disposal of the animal.
- The fair will maintain an incident report on all animal injuries and/or deaths.

## **Policy for Handling Animal Rights Issues**

### **For all fair personnel:**

All inquiries from the public, media, or representatives of animal advocacy groups regarding the care or management of animals should be directed to the appointed spokesperson.

In the event of a demonstration, reference should be made to the safety policies of the fairgrounds.

Any activity or demonstration that is disruptive for fair visitors, exhibitors or livestock must be handled by the police. The fairgrounds are considered private property; therefore, anyone engaging in activities that are not in the best interest of the fair may be evicted.

**For exhibitors:**

If approached by representatives of animal advocacy groups, exhibitors must politely refer them to the fair office.

Under no circumstances should an exhibitor engage in debate about animal rights issues or opinions. Confrontation is to be avoided at all costs.

**VISITOR CODE OF CONDUCT**

---

To ensure the best possible experience for all our guests, we ask that you respect all applicable laws, our rules and guidelines as listed below (posted on the fairgrounds).

Your access to Brome Fair is conditional on your acceptance of these terms. We reserve the right to remove you from the premises if you are found to be in violation of any of them.

**GENERAL TERMS**

1. Brome Fair is not responsible in any way for animals/items lost or stolen on the fairgrounds. Nor shall it be responsible for any damage caused by an accident on the fairgrounds.
2. No unauthorized pets/animals are permitted on the fairgrounds
3. Smoking is strictly prohibited in all buildings on the fairgrounds
4. Tickets & passes are non-exchangeable, non-refundable, revocable, and void if altered, lost, stolen or fraudulent.
5. Security screenings are in place at all entrances and within the fairgrounds. All guests and their belongings may be subject to such screening. Guests declining to be searched will not be permitted into the fairgrounds.
6. We reserve the right to refuse entry to the fairgrounds of any bag, parcel, or other items. We also reserve the right to deal with any unattended object in such way as we consider appropriate. Prohibited items should be kept at home, stored in your vehicle, or voluntarily surrendered at the entrance. Items will not be returned.
7. Any form of verbal or physical abuse to fellow Fair guests, volunteers, and employees will not be tolerated and will be grounds for immediate removal from Fair with no refund.
8. Laws prohibiting consumption of alcoholic beverages by minors, illegal drugs, and disorderly conduct of any kind will be strictly enforced. Guests arriving intoxicated will not be admitted into Fair.
9. Access to attractions or venues at Fair may be subject to additional terms and conditions. We have the exclusive right to determine whether you have satisfied any condition necessary to access an attraction or venue.

10. Amusement rides are available. All participants are expected to act in a responsible manner at all times and obey all oral/written guidelines.
11. The following activities are strictly prohibited:
  - a) Acts of demonstration, solicitation, distribution, or private sale of materials unless pre-authorized by Brome Fair personnel.
  - b) The distribution of printed or recorded materials of any kind.
  - c) Photography, videotaping or recording of any kind for commercial purposes.
  - d) Engaging in any unsafe act that may impede the operation of Fair or any associated venue.
  - e) Operating golf carts, ATV's and 4 wheelers on the fairgrounds without prior authorization from Brome Fair.
12. We may photograph, film, videotape, record or otherwise reproduce the image and/or voice of any person attending Brome Fair. These may be used for journalistic, advertising, marketing, promotional, archival and/or security activities without payment or compensation made to any person. You consent to this by entering the fair.
13. We reserve the right to deny admission or to require a person already admitted to leave Fair, without refund, liability or compensation if we consider that the circumstances so require.
14. We reserve the right to, without prior notice and without refund, liability or compensation, change the operating hours of Fair or any attraction, close Fair or any part of it temporarily, restrict the number of persons having access to Fair, and/or suspend or cancel any attraction or entertainment program if we consider that the circumstances so require.
15. This Code of Conduct is subject to change without notice. Changes may be made to, for example, reflect changes in our legal or regulatory obligations. Accordingly, we encourage each of our guests to refer back to it on a regular basis prior to attending Fair.

## **ADDITIONAL TERMS**

We endeavor to make your time at Fair as safe and enjoyable as possible.

Please be aware, however, that there are risks inherent to your visit, including being exposed to or infected with COVID-19. An inherent risk of exposure to COVID-19 exists in any public place where people are present.

By visiting the Fair, you voluntarily assume all risks and dangers connected to, associated with or incidental to your presence at Fair. We are not responsible under any circumstances for any loss, injury (including personal injury or death), illness, damage or liability that may arise out of or is in any way connected to your presence at Fair regardless of whether such loss, injury, illness, damages or liability arises

from negligence, libel, defamation, loss of privacy, COVID-19, testing or screening for COVID-19 or otherwise.

## **PROHIBITED ITEMS**

The following items may not be brought into Fair:

- Alcohol, drugs & drug paraphernalia
- Weapons & replica weapons of any kind (knives, firearms, tasers, etc.)
- Explosives
- Corrosive chemicals
- Flammable substances
- Bicycles/scooters/segways/skateboards
- Hand tools/electric tools
- Drones/Radio Controlled devices
- Mace/pepper spray/bear spray
- Paint
- Pets/other animals except animals with a Service Dog Identification Card
- Banners/signs/voice amplification devices
- Air horns/artificial noisemakers
- Materials of an extremist/offensive /discriminatory nature
- Pad locks/chains/cables/zip ties/handcuffs
- Any item deemed a danger/threat to public order or safety

# DAIRY CATTLE

## RULES AND REGULATIONS

### NEW THIS YEAR

1. Parade: Junior, Reserve Junior, Senior, Reserve Senior, Grand and Reserve Grand Champions must be in the parade or forfeit prize money. All other exhibitors are welcome to participate on a voluntary basis.
  2. Bedding: One (1) bag of shavings or straw bale per head present, up to a maximum of ten (10), will be supplied to dairy exhibitors on a daily basis.
  3. All cattle to be on grounds no later than **10 a.m. on Friday**. Dairy can depart Monday as of 5:15pm.
4. All **entry forms**, applicable fees and certificate of insurance must be in the office of the administration by **August 10th, before 8:00 p.m.** Mandatory full ATQ # on entry form or animal will not be accepted. Entries received after this date will not be accepted. When stable accommodation is full, entries will be returned.
  5. Maximum number of animals per exhibitor, per breed, is **ten (10)**, calves included.
  6. **Substitutes:**  
All substitute animals must be declared in writing by email no later than 5 pm Wednesday before fair to appear in the show catalogue. Any substitutes made afterwards will not be recorded in the show catalogues. **Only three (3) animals will be eligible for substitution.** Substitute animals will be confirmed at the same time as registration certificates are checked. The total number of animals exhibited at fair cannot exceed the quantity entered, excluding substitutes.
  7. Registration certificates must accompany animals and will be checked Friday afternoon. All exhibitors must be available for verification during these times.
  8. Three (3) exhibitors and twenty-four (24) head per breed is required for judging.
  9. **Judging**                      All Breeds                      Saturday, 10:00 am
  10. **No cattle washing anywhere except at wash rack.**
  11. No blocking chutes or fans will be allowed in the aisles behind cattle during the fair.
  12. No wood chips or dirt allowed for bedding. Only straw or shavings may be used. Bedding must remain within designated floor markers. No Large Bales.
  13. Tampering: Unnatural practices in fitting will not be tolerated and all cattle entered for competition shall be presented in the judging ring in their natural conformation and natural physical condition.



- 14. Breeding:** In cases where doubt exists in the mind of the judge or official as to the breeding capability of an animal, the exhibitor may be required to furnish evidence to the satisfaction of the official concerned
- 15. Championship Ribbons -all breeds:** All animals must have been shown in regular classes.
- 16. Code of ethics for dairy exhibitors:**  
The following practices or procedures are considered unacceptable and defined as being unethical in the show ring of registered dairy cattle. In registering, all breeders and exhibitors are engaged in the respect and observance of the Code of Ethics.
- a) Misrepresenting the age of the animal for the class in which it is shown.
  - b) Balancing the udder by any means other than by leaving naturally produced milk in any or all quarters.
  - c) Treating or massaging any parts of the animal's body, particularly the udder, internally or externally with an irritant, counterirritant, or other substances, to temporarily improve conformation or produce unnatural animation.
  - d) Minimizing the effects of cramp or lameness by feeding or injecting drugs.
  - e) Surgery of any kind performed to change the natural contour of appearance of the animal's body, hide or hair. Not included is the removal of warts, teats, and horns, clipping and dressing the hair and trimming of hooves.
  - f) Insertion of foreign material under the skin.
  - g) Criticizing or interfering with the judge, show management or other exhibitors while in the show ring, or other conduct detrimental to the breed or show.
- 17. Production records:** Not required.
- 18.** All exhibits must be registered in the name of the exhibitor in accordance with the by-laws of their respective association. The certificate of registration **must** state that the animal is **purebred** or at least 75% of purebred inheritance. All exhibits must be legibly tattooed (if applicable).
- 19. Competition for Herdsman**  
Open to any exhibitor showing dairy cattle and exhibiting a minimum of six (6) animals. To be awarded to the herdsman or to the owner of the exhibit.

**Regulations:** To be eligible, a cow must have been shown in an individual regular class with a placing among the top three. Also, the cow must be registered in a recognized milk control program and be classified.

## RULES AND REGULATIONS

### NEW THIS YEAR

1. All cattle to be on grounds no later than **10 a.m. on Friday**. All animals must remain on the grounds until **3 p.m. Monday**. Exception: Out of province exhibitors may depart Sunday after 7 p.m.
  2. **Judging**  
Saturday: 10:00 am (Schedule to be posted prior to fair)
  3. **Bedding:**  
One (1) bag of shavings or straw bale per head present, up to a maximum of ten (10), will be supplied to beef exhibitors on a daily basis.
  4. **Parade:**  
All Junior, Reserve Junior, Senior, Reserve Senior, Grand and Reserve Grand Champions must be in the parade or forfeit prize money. All other exhibitors are welcome to participate as on a voluntary basis.  
Suggested beef dress code: breed colors or farm colors.
- 
5. Provincial Show:
    - a) While Brome Fair remains open to residents from any province, Quebec residents exhibiting in these sections will also be competing in the Provincial Championships.
    - b) There must be a minimum of five (5) animals competing for each Championship class to maintain Provincial status.
  6. All entry forms, applicable fees and certificate of insurance must be in the office of the administration by **August 10th, before 8:00 p.m.** Mandatory full ATQ # on entry form or animal will not be accepted. Entries received after this date will not be accepted. When stable accommodation is full, entries will be returned.
  7. No blocking chutes or fans will be allowed in the aisles behind cattle during the fair.
  8. No wood chips or dirt allowed for bedding. Only straw or shavings may be used. Bedding must remain within designated floor markers. No Large Bales.
  9. Tampering: Unnatural practices in fitting will not be tolerated and all cattle entered for competition shall be presented in the judging ring in their natural conformation and natural physical condition.
  10. Breeding: In cases where doubt exists in the mind of the judge or official as to the breeding capability of an animal, the exhibitor may be required to furnish evidence to the satisfaction of the official concerned

11. **Championship Ribbons** -all breeds: All animals must have been shown in regular classes.
12. **No cattle washing anywhere except at wash rack.**
13. Three (3) exhibitors and eighteen head per breed is required for judging.
14. **Restraint of bulls:** Any bull exceeding twelve months of age must be restrained using a ring or humbug. This rule applies at any and all times this animal is being handled on the grounds. Failure to comply with this rule will result in instructions from the Board of Directors to remove the animal from the show and possibly from the premises
15. **Definitions**
- a) An **exhibit** is a unit of livestock qualifying for any entry into a class as specified in the classifications. All registered animals, whether owned by one person or by more than one person, individually or jointly, are considered to be the production of one farm or breeding unit on which they are maintained.
  - b) An **exhibitor** is any breeder or firm which presents animals or farm produce for official placing by a judge at the time specified for judging.
  - c) In each classification where the same or common interests are involved in more than one breeding operation such operations are considered as one **Breeding unit**. In all cases where there is any doubt that more than one breeding unit exists, the interpretation shall be that only one breeding unit exists. The responsibility of proof of separation of breeding units shall rest with the exhibitors.
  - d) **Purebred** means an animal of the breed as determined by the by-laws of an association authorized to register animals of that breed.
16. **Checking of exhibits:** Checking of exhibits is the responsibility of the fair committee. The committee must exclude ineligible animals and those not positively identified before judging.
17. **Split classes:** For all species, classes may be split at the discretion of the fair committee. Each split class is considered a separate class, by definition.
18. **Number of exhibits per breeding unit:** All exhibits must be owned by and registered as purebred in the name of the exhibitor. Note exceptions in the Get of Sire and Breeder's Herd classes. There is no restriction on multiple exhibits in any classes excluding the Breeder's Herd and Get of Sire class.
19. The maximum number of animals per exhibitor for all beef breeds is **fourteen (14)**, calves included. BCAS reserves the rights to reduce the number of entries in order to accommodate all the breeds in the barn space allotted.
20. **Animal registration:** All animals being shown in single classes must be registered as purebred by the closing date of entries, except calves under three months of age, which must be properly tattooed in two year and mature cow/calf classes. All animals must be legibly tattooed. Calves over three months of age must be registered unless the by-laws of an association states that an animal cannot be registered until older.

21. Only one camping trailer allowed per exhibitor or breed entered by the exhibitor.

22. **Competition for Herdperson**

Open to any exhibitor showing beef cattle and exhibiting a minimum of six animals. To be awarded to the herdperson or to the owner of the exhibit.

One \$50.00 award per breed will be allotted based on following criteria.

Neatness & information	40%
Grooming	30%
Courtesy	30%

23. All animals in section 322 must be registered.

24. **Substitutes:**

Substitute animals are no longer to be listed on entry forms. They are to be declared upon arrival the Friday before fair. **Only three (3) animals will be eligible for substitution.** Substitute animals will be confirmed at the same time as registration certificates are checked. All animals listed on the entry form will be on the show program, while substitutes will only be listed on the judge's sheet. The total number of animals exhibited at fair cannot exceed the quantity entered, excluding substitutes.

25. Registration certificates must accompany animals and will be checked Friday afternoon. All exhibitors must be available at this time for verification.

## RULES AND REGULATIONS

---

---

1. Provincial Show:
  - a) While Brome Fair remains open to residents from any province, Quebec residents exhibiting in these sections will also be competing in the Provincial Championships.
  - b) There must be a minimum of 5 exhibits competing for each Championship class to maintain Provincial status.
2. Three (3) exhibitors and ten (10) exhibits per breed is required for judging.
3. A minimum of three (3) exhibits per class is required for judging.
4. The age of exhibits is calculated according to their age on August 1<sup>st</sup>.
5. The maximum total eligible exhibits from a breeding unit per breed is fifteen (15). An exhibitor may place these in the appropriate classes. No limit per class.
6. **Substitutes:** Substitute animals will be confirmed at the same time as registration certificates are checked Thursday before fair. All animals listed on the entry form will be on the show program, while substitutes will only be listed on the judge's sheet. The total number of animals exhibited at fair cannot exceed the quantity entered, excluding substitutes.
7. Entry forms including applicable fees and certificate of insurance must be in the office of the administration by **August 10<sup>th</sup>, before 8:00 p.m.** The post mark is not considered.
8. A **\$25 exhibitor's fee** must accompany each entry form.
9. All goats to be on grounds no later than midnight on Thursday. All animals must remain in stalls until **5:30 p.m. Monday.**
10. Registration certificates must accompany animals and will be checked Friday morning from 9:00 a.m. to 12:00 p.m. All exhibitors must be available for verification during these times.
11. All animals must be legibly tattooed, and tattoos must match the original registration papers.
12. An official health check will be conducted on site by either a veterinarian or a group of three members of the Canadian Goat Society (dairy goats, angora goats) or the Canadian Meat Goat Association (Boer goats)
13. The shows will be sanctioned by the Canadian Goat Society (dairy goats, angora goats) and the Canadian Meat Goat Association (Boer goats).

15. All animals shown in group classes must have been shown in their regular classes.

19. During judging, only the judge, the Brome Fair goat committee members and the exhibitors will be permitted in the judging enclosure.
20. **Competition for Herdsman**
- This competition is open to any herdsman or owner-exhibitor showing a minimum of five (5) animals in the goat classes. (\$40, \$30, \$20, \$10). All exhibitors are considered for this competition.
- Basis of the award:** For the best display of goats, not including the quality of the goats themselves. At least fifty percent to be allotted for general neatness of the exhibit and for grooming of the goats. The remaining fifty percent to include courtesy of the herdsman and information provided to the public as well as other factors to be determined by the goat committee. Judging will consider all factors involved in an all-day operation of Friday, Saturday, Sunday and Monday 7am. to 10p.m.

# HORSES

## RULES AND REGULATIONS

### NEW THIS YEAR

1. Youth/Child exhibitors must have their horse/pony stabled by 8 p.m. every night.
2. No additional changes to classes on the track. Changes may be made by Thursday morning at the Horse office from 8 – 9 a.m. and Friday morning from 8 – 9:30 a.m. No additions or changes to classes will be permitted after 9:30 a.m. on Friday.
3. **Arrival and Departure**
  - a) **Riding and Driving**

**Arrival:** Any exhibitor competing in a riding or driving class must be on the fairgrounds Thursday by 9 p.m.

**Departure:** Monday after 3 p.m.
  - b) **Halter**

**Arrival:** Exhibitors competing solely halter classes (sections 101 to 105, 140 to 147, 150, 154, 155, 160, 161, 165) must arrive Thursday between 6 a.m. and 8 a.m.

Alternatively, they may request stabling for Wednesday night (racehorse paddocks if all other stabling is assigned). This must be indicated on their entry form. Arrival on Wednesday only between 12 p.m. and 9 p.m. Arrangements must be made with the Brome Fair office if they wish to arrive before.

All trailers must check in at the Horse Office before unloading.

**Departure:** They are required to leave Thursday after 4 p.m.
4. Provincial Show:
  - a) While Brome Fair remains open to residents from any province, Quebec residents exhibiting in these sections will also be competing in the Provincial Championships.
  - b) There must be a minimum of 5 animals competing for each Championship class to maintain Provincial status. (Compensation money)
5. **All entry forms**, applicable fees and certificate of insurance must be in the office of the administration **before 8pm, August 10<sup>th</sup>**. Entries received after this date will not be accepted and the post mark will not be taken into consideration.

When stable accommodation is full, entries will be refused, and entry fees will be returned.

6. A \$25 exhibitor fee must accompany each entry form.
7. On making entries, the owner's name and address in full, the name of the animal (if named) and the age should be given. A copy of the registration form must accompany entry form for all registered horses.
8. **ALL HORSES AND PONIES MUST HAVE A CLEAR COGGINS TEST FOR THE CURRENT YEAR OF FAIR.** It is not necessary to mail it with the entry form. The original certificate must accompany the animal on arrival at the grounds. No horse will be stabled without certificate.
9. No tie out allowed.
10. Horse exhibitors are to enter at gate C and proceed to the horse committee office located in the stabling area. Horses are not to be unloaded until registration papers and proof of Coggins test is verified.
11. All stalls must be cleaned by **5:00 p.m. Monday**, leaving the manure in the alley. Any exhibitor not leaving the stall clean will forfeit their prize money.
12. No addition to classes will be allowed after August 10<sup>th</sup>.
13. If only one animal is exhibited in a class or section, the judge can use his own discretion as to awarding a premium. He shall in no case award a prize unless he considers the exhibit worthy of such a premium.
14. Registration papers must be shown with the horse before the judging. Current year foals that are not fully registered must have a Canadian National Livestock record pre-registration. Registered horses may not compete in Grade classes. All registered breeding classes must be registered with Canadian Livestock Records, Ottawa.
15. Brood mares must show evidence of being in foal or have raised a foal during the current year. The exhibitor is required to show the foal at foot or registration certificate of the foal must be provided if the foal is not shown.
16. Pairs of horses can be shown both in pairs and single. The single horse and the pair must be those entered and owned by the exhibitor.
17. Any person showing registered animals as grade will be disqualified. All draft horse geldings are to be shown as grade animals.
18. All classes with age restrictions must be substantiated by showing proof of age. A photocopy of their Medicare card must be submitted with the entry form. All ages are to be as of January 1<sup>st</sup> of the year of the fair.
19. Exhibitors must dress appropriately for all horse classes & the parade.
20. Exhibitors are not permitted to address the judge. If an exhibitor feels there is a problem, he may approach the ringmaster or the show manager.
21. Horses that are ridden or driven during the competition must be ridden or driven in Sunday's parade, not paraded on halter, or exhibitors will forfeit their prize money.

22. All horses must be washed at the washstand. No washing near the barns.
23. All stalls are to be kept clean and tidy at all times. The horse committees reserve the right to verify.
24. All camping areas must be kept neat and tidy.
25. Definitions:
- a) **An exhibit** shall be interpreted as follows: one or more units of livestock qualifying for any entry into a class as specified in the classifications. All registered animals, whether owned by one person or by more than one person, individually or jointly, are considered to be the production of one farm or breeding unit on which they are maintained.
  - b) An **exhibitor** is any breeder or firm which presents animals or farm produce for official placing by a judge at the time specified for judging.
  - c) In each classification where the same or common interests are involved in more than one breeding operation such operations are considered as one **breeding unit**. In all cases where there is any doubt that more than one breeding unit exists, the interpretation shall be that only one breeding unit exists. The responsibility of proof of separation of breeding units shall rest with the exhibitors.
  - d) **Purebred** means an animal of the breed as determined by the by-laws of an association authorized to register animals of that breed
26. **Checking of exhibits** is the responsibility of the fair committee. They will exclude ineligible animals and those not positively identified before judging.
27. **Split classes.** For all species, classes may be split at the discretion of the judge when the number of exhibits is deemed excessive. The two sections will still be viewed as one single class.
28. **Animal registration.** All exhibits must be owned by and registered as purebred in the name of the exhibitor. Note exception in the Get-of-Sire class. Registration of each heavy horse must accompany the entry, or, in the case of spring and summer foals, a breeding certificate must be available.
29. **No smoking.** Smoking in the horse barns is strictly prohibited.
30. No motorized vehicles, stock or flatbed trailers are permitted to be parked between the horse barns. Parking will be available in the back.
31. **Exhibitors' Competitions (Separate prizes for Heavy & Light horses)**

1. Provincial Show:
  - c) While Brome Fair remains open to residents from any province, Quebec residents exhibiting in these sections will also be competing in the Provincial Championships.
  - d) There must be a minimum of five (5) animals competing for each Championship class to maintain Provincial status.
2. A minimum of three (3) exhibitors and ten (10) head per breed is required for judging.
3. A minimum of three (3) head per class is required for judging.
4. The maximum eligible exhibits from a breeding unit per breed is fifteen (15).
5. Entry forms including applicable fees and certificate of insurance must be in the office of the administration by August 10<sup>th</sup>, before 8:00 p.m. The post mark will not be considered.
6. A \$25 exhibitor fee must accompany each entry form.
7. All sheep must be on the grounds by Thursday at 1:00 p.m. and must remain on grounds until **5:30 p.m. Monday**.
8. Registration papers to accompany each animal at the exhibition. All entries must be owned by and registered in the name of the exhibitor.
9. For the purpose of the classification, an exhibit shall be defined as follows: All purebred registered animals, whether owned by one person, or by more than one person, individually or jointly which are maintained on one farm or breeding unit, are considered to be the production of one farm or breeding unit.
10. In each classification where the same or common interests are involved in more than one breeding operation, such operations are considered as one breeding unit. In all cases where there is any doubt that more than one breeding unit exists the responsibility of proof of separation of breeding units rests with the exhibitor.
11. During judging, only the judge, the Brome Fair sheep committee members, and exhibitors will be permitted in the judging enclosure.
12. The sequence will be rotated annually: **2022 – Section 530**.
13. **Substitutes:**

Substitute animals will be confirmed at the same time as registration certificates are checked Thursday before fair. All animals listed on the entry form will be on the show program, while substitutes will only be listed on the judge's sheet. The total number of animals exhibited at fair cannot exceed the quantity entered, excluding substitutes.

**14. Judging:**       **Sunday** at 10:00 a.m.

**15.** All breeds must be shown in short fleece, staple less than one inch, except Leicester.

**16. Championship Classes:** For best ram and best ewe, any age, for each breed. Animals must be shown in regular classes. Ribbons only.

**17. Competition for Herdsman**
